

## International Student Financial Guarantee

The United States Citizenship and Immigration Services regulations require that all international applicants on the F-1 visa provide evidence of sufficient funds to pay costs of attendance. A completed financial guarantee and original supporting bank documentation must be received by International Student Services prior to the issuance of Form I-20. Incomplete documentation will delay the admissions process.
