NEED SUMMER FUNDS?

If you are enrolled for the Summer 2023 semester, the Office of Financial Aid will update your financial aid for you! How Awesome is that!

<u>Please remember the following:</u>

-If you attended full-time in Fall22 and Spring23, you MUST be enrolled in at least 6 credit hours during Summer23 to be eligible to receive grant funds

-To receive student loan funds, you MUST be enrolled in at least 6 credit hours during Summer23. PLEASE CONTACT YOUR FINANCIAL AID COUNSELOR FOR THE FORM

CONGRATULATIONS GRADUATES

Student loan borrowers who have graduated, obtained a degree, or have dropped below 6 credit hours are required to complete Exit Counseling.

Exit counseling is found on the Federal Student Aid website at https://studentaid.gov.

You must use your FSA ID and Password to log in.



Repayment of your student loans will begin 6 months after you graduate or if you drop below 6 credit hours. Typically, your loan servicer will notify you of their contact information, but you can also obtain this information when you complete Exit Counseling. It is suggested that you reach out to your loan servicer to discuss your repayment options, deadlines, and if needed, deferment options. If you are having problems repaying your student loans, contact your loan servicer to discuss the options available to you. **DO NOT** ignore them or fail to make plans or repayment arrangements. This may cause you to **DEFAULT** on your loans which will have a negative impact on your credit.

FAFSA

The financial aid filing season officially began Oct 1, 2022, with the launch of the 2023-2024 FAFSA (Free Application for Federal Student Aid).

Once the FAFSA is processed, CCGA will use the FAFSA information to calculate the amount and types of financial aid for which the student may be eligible.

<u>CCGA's priority deadline</u> to have all additional documentation received in our office is <u>June 1st.</u> Please be reminded that some aid is limited, so the sooner you get your file completed the better.

HOPE CHECK-UP

Students are evaluated to ensure their eligibility ("B" average= 3.0 Financial Aid GPA) for Hope Scholarship at the following <u>checkpoints:</u>

- 30 attempted semester hours
- 60 attempted semester hours
- 90 attempted semester hours
- End of every Spring Semester

If you currently do not receive the Hope
Scholarship and you are at one of the following
checkpoints at the end of the semester and have
a 3.0 GPA; complete the Hope Evaluation Form
located on your CCGA Portal once final grades
have been posted. If you are a transfer student
and had Hope/Zell at your prior college; complete
the Hope Evaluation Form located on your CCGA
PORTAL

IF YOU HAVE AUTHORIZED, CHECK CREDIT

- *SELECT A TERM THEN CLICK SUBMIT (IF REGISTERED YOU WILL SEE TUITION AND FEES AS WELL AS AUTHORIZED AID. "ACCOUNT BALANCE NET OF AUTHORIZED FINANCIAL AID" IS NEGATIVE MEANS YOU HAVE A CREDIT AVAILABLE. IF SCHEDULE IS ALTERED CREDIT WILL NOT BE AVAILABLE FOR 24 HOURS.)

*LOG IN WITH YOUR STUDENT ID AND CCGA PASSWORD

*COMPLETE THE ELECTRONIC FORMS AND UPLOAD ALL OF THE REQUIRED DOCUMENTATION THE FORM REQUESTS. (YOU WILL NOT BE ABLE TO SUBMIT YOUR VERIFICATION WITHOUT ALL OF THE REQUIRED DOCUMENTATION)

(NOTE: DEPENDENT STUDENTS AND PARENTS: STUDENTS WILL SUPPLY THE PARENT'S EMAIL ADDRESS ON THE FORM. THE PARENT MUST CLICK THE LINK IN THEIR PERSONAL EMAIL ADDRESS TO ACCESS THE FORM IN

CCGA.STUDENTFORMS.COM. PARENTS MUST CREATE THEIR OWN ACCOUNT.)

**IF YOU HAVE ALREADY COMPLETED YOUR 2023-2024 FAFSA, IT IS HIGHLY SUGGESTED THAT YOU CREATE A CCGA.STUDENTFORMS.COM ACCOUNT EVEN IF YOU ARE NOT SELECTED FOR VERIFICATION

HOW DO I GET TO THE ELECTRONIC DYNAMIC FORMS?

- *LOGIN TO THE PORTAL WITH STUDENT ID AND CCGA PASSWORD
- *CLICK THE STUDENT FORMS TAB AT THE TOP
- *SELECT FINANCIAL AID FORMS
- *SCROLL TO SEE ELECTRONIC FORMS
- *CLICK NEEDED FORM UNDER APPROPRIATE AID YEAR


*COMPLETE THE ELECTRONIC FORM, SIGN ELECTRONICALLY AND SUBMIT (NOTE: DEPENDENT STUDENTS AND PARENTS: STUDENTS BEGIN FORM BY INPUTTING PARENTAL INFORMATION AND SAVE, THEN CLICK "CONTINUE TO FORM". STUDENT COMPLETES THEIR SECTION OF THE FORM, SIGNS ELECTRONICALLY AND THEN SUBMITS. THEN THE PARENT WILL GET AN EMAIL TO COMPLETE THEIR SECTION. PARENT CLICKS LINK IN EMAIL, [PARENT MUST SET UP ACCOUNT IF THEY ARE A NEW USER] THEN LOGS IN AND COMPLETES THE PARENTAL SECTION. REMEMBER SEE FORM TITLE AT THE TOP OF EACH PAGE, IF SECTION IS GRAYED OUT IT IS NOT TO BE COMPLETED BY LOGGED IN INDIVIDUAL.)

NOT MAKING SAP/APPEAL

YOU HAVEN'T MET ONE OR MORE REQUIREMENTS AND ARE NO LONGER ELIGIBLE FOR A WARNING. YOU MAY APPEAL TO REINSTATE YOUR FINANCIAL AID.

TAKE ACTION

- FILE A SAP APPEAL THROUGH THE CCGA PORTAL AT STUDENT FORMS
- MEET WITH YOUR FINANCIAL AID COUNSELOR FOR ASSISTANCE

Course Program of Study (CPoS)

The U.S. Department of Education (ED) regulations require that a student must be enrolled in a degree-seeking program to receive federal financial aid (Grants, Loans, FSEOG, Work Study). Funds will only be disbursed for courses that will fulfill unmet degree requirements, including applicable prerequisite/corequisite courses. Students enrolling in courses that will not aid in completing their degree may see their financial aid prorated and/or canceled as required by the Department of Education. Students are required to meet with their academic advisor before they register each semester; students should use that opportunity to ensure all courses aid in degree completion.

What is CPoS?

Course Program of Study (CPoS) is the process that is run to identify which courses will fulfill unmet degree requirements, including applicable prerequisites/corequisite courses. Courses that will not aid in degree completion will be ineligible for federal financial aid. The CPoS process will run regularly throughout the registration period before and after classes begin, and students will be notified via their student email and messaged within the portal if they are registered for classes that will not count toward their degree.
